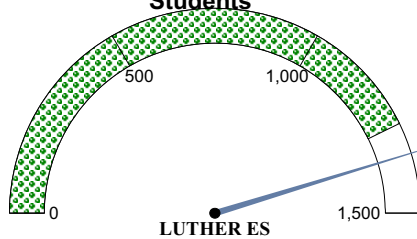

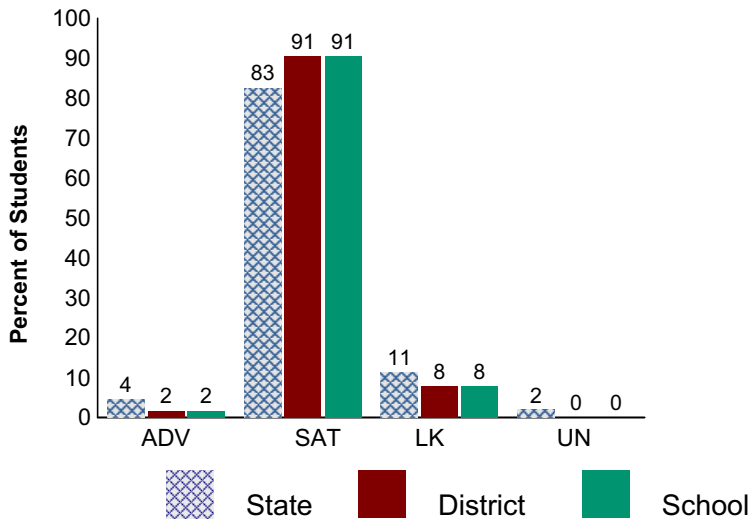

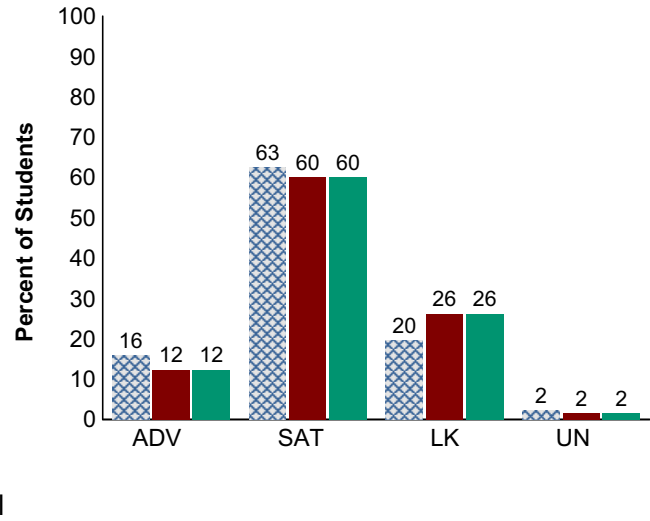
**State, District, and School Reading Results**

All Students Tested



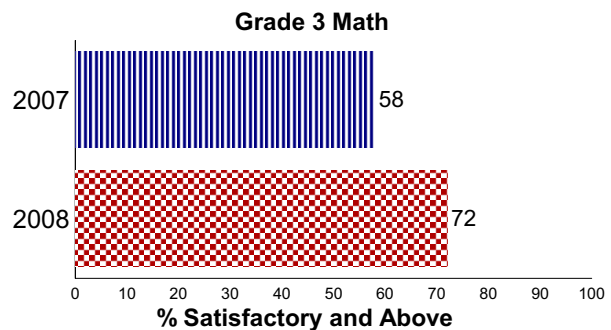
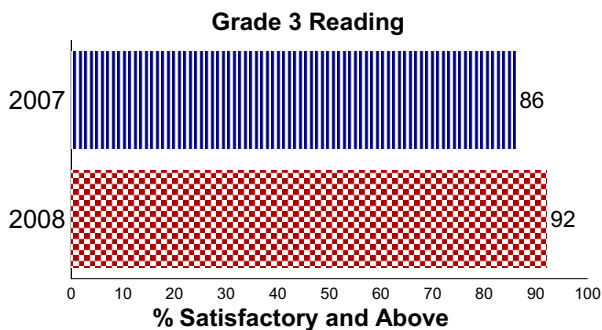

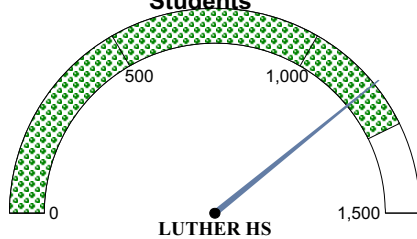

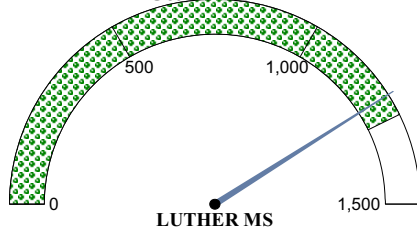
